Annual Report of the Chair Kathy Peake

Mobility Assistance Dogs Trust (CC24410) For the year ended 31 March 2024

I am privileged to be Chair of Mobility Assistance Dogs Trust (MADT).

The last financial year has been successful as we continue to enhance the wellbeing and independence of all New Zealanders through the diversification of our programmes proudly raising and training Mobility, Court, Therapy, Companion, School and Dental Dogs.

Despite strong support, funding remains a challenge due to the number of charities, the current economic situation and rising cost of living. While we value all donations, grants and bequests, special thanks go to the Lindsay Foundation, Chillisoft, Lion Foundation, Foundation North, and the Joyce Fisher Charitable Trust for their ongoing support.

This year we placed nine dogs across New Zealand: three Mobility Dogs for individuals with physical disability, four Companion Dogs, one Court Dog and one School Dog. The latter is near the end of its six-month pilot study and once this is fine-tuned, we expect more schools to come on board in the coming year. We aim for 10-12 placements annually and anticipate an increase with our expanded range of services.

We manage 62 placed dogs, have 17 in training (with the arrival of six more puppies imminent), and eight dogs in our Puppies in Prison programme at Wiri Women's prison.

Our General Manager, Jody Wilson, notes that the number of dogs placed does not reflect their impact. One dog changes many lives with the marked ripple effect on the family, support network and community. The is also a tangible impact on mental health and general well-being.

We are incredibly fortunate to be one of only three service dog organisations in New Zealand accredited by Assistance Dogs International, "the global authority in the Assistance Dogs industry", and we continue to strive to exceed these standards.

Assistance Dogs International and the International Guide Dog Federation, cognisant of the emotional capacities of dogs, have strengthened their commitment to the health, welfare and ethical treatment of Service Dogs by all member programs. At Mobility Dogs, the welfare and well-being of our dogs is central to our mission.

As the only Service Dog organisation involved in the New Zealand Court Dog programme, we have three Court Dogs placed in Auckland and Tauranga, with another recently signed up. This would not be possible without the support and relationship with the founding body Courthouse Dogs in the USA.

New developments include:

Establishing the Mobility Dogs Investment Trust to enhance our fiscal responsibility and accountability, with thanks to Hamilton Locke for their pro bono work.

Welcoming our first fundraiser to boost our funding and marketing efforts.

Announcing that Robyn Scott-Vincent has joined our team as Trustee. Robyn, as Founder, Director and Executive Producer of Attitude Pictures Ltd and attitudelive.com, brings invaluable experience from both disability and commercial sectors.

Finally, a huge thank you to our team. Though small, we are mighty, and the commitment of our General Manager, Canine and Administration teams, Board members (voluntary), and volunteers make our life changing work possible. Special thanks to those who breed and assist us acquire the best puppies for our clients.

Main Sources of Entity's Cash and Resources

The Trust's activities are primarily funded through donations and grants received from individual, corporate, trust and community funders. From time-to-time the Trust also undertakes fundraising activities.

Entity's Reliance on Volunteers and Donated Goods or Services

In partnership with the Department of Corrections, the Trust relies on the time of prisoner handlers who work with the Trust's staff to raise and train dogs as part of the Puppies in Prison programme.

The Trust works with volunteers in Northland, Auckland, Hamilton and Southern Lakes who assist us to raise and socialise dogs as part of our puppy development programmes. The trust receives food for all dogs in training from its corporate sponsor Mars New Zealand. We also rely on volunteers from the community and our corporate partners to support other activities such as fundraising or awareness.

Volunteer Puppy Raisers - Our team worked closely with our volunteer puppy raisers over the last year to ensure good outcomes for all our trainee Mobility Dogs aged from 8 weeks to 2+ years. During the financial year ending 31 March 2024 we were supported by 41 full time volunteer puppy raisers in Auckland, Hamilton, Whangarei and Southern Lakes.

Puppies in Prison - Throughout the year, new prisoners are inducted into the programme as others graduate or leave to other roles. This programme continues to be a crucial part of our service, allowing us to achieve our primary goal of training more Mobility Dogs. Currently, 100% of our dogs are trained, in part, by prisoners on this programme. A secondary objective of the programme is that it provides skill development and pro-social outcomes for the prisoners.

Clients - We have placed **9** new Mobility Dog partnerships in a variety of settings and we continue to support all of our current clients for the lifetime of their dogs. These placements are divided into the following categories; Court Dogs, School Dogs, Companion Dogs, Therapy Dogs, Mobility Dogs. All of these dogs are individually trained to meet the needs of the clients.

Public Access Assessments In order to adhere to the requirements of our Accreditation with Assistance Dogs International, and, to meet our commitment to the ongoing support of our clients and dogs we completed **42** annual Public Access Assessments nationwide. This is to ensure that our dogs can work safely in the community and exhibit the behaviors we would expect from a disability assist dog.

Statement of Accounting Policies

Mobility Assistance Dogs Trust (CC24410) For the year ended 31 March 2024

Basis of Preparation

The entity has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Financial Statements is prepared under the assumption that the entity will continue to operate in the foreseeable future.

Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

Income Tax

Mobility Assistance Dogs Trust (CC24410) is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

Significant Accounting Policies

Revenue

Donations, sponsorship and fundraising

Revenue from donations, sponsorship and fundraising are recognised when the funds are received.

Revenue from grants is recognised when the funds are applied to the relevant expense.

Placement fees

Revenue associated with the provision of trained dogs is recognised when an approved applicant's dog is ready for placement.

Interest Revenue

Interest Revenue is recorded as it is earned during the year.

Employee Related Costs

Wages, salaries and annual leave are recorded as an expense as staff provide services and become entitled to wages, salaries and leave entitlements.

Performance payments are recorded when the employee is notified that the payment has been granted.

Superannuation contributions are recorded as an expense as staff provide services.

Debtors

Debtors are initially recorded at the amount owed. When it is likely the amount owed (or some portion) will not be collected, a provision for impairment is recognised and the loss is recorded as a bad debt expense.

Property, Plant and Equipment

Property, plant and equipment is recorded at cost, less accumulated depreciation and impairment losses.

Depreciation is provided on both a straight-line and diminishing value basis, with the associated depreciation rates of the major classes of assets and useful lives (where applicable) estimated as follows:

Computer Equipment	Straight-line, 2.5 years (40%), Diminishing value (40%-50%)
Plant & Equipment	Straight-line, 3 to 6 years (17.5 % to 30%), Diminishing Value (13.5% - 67%)
Motor Vehicles	Diminishing value (20% to 30%)

Creditors and Accrued Expenses

Creditors and accrued expenses are measured at the amount owed.

Employee Costs Payable

A liability for employee costs payable is recognised when an employee has earned the entitlement. These include salaries and wages accrued up to balance date and annual leave earned but not yet taken at balance date.

Tier 2 PBE Accounting Standards Applied

The Trust has not applied any Tier 2 Accounting Standards in preparing its financial statements.
